ORDER

Subject: Guidelines for registration of OEMs and New model(s) under FAME India Scheme - regarding.

In supersession of this Department's Office order of even number dated 21st August, 2018, the decision of the competent authority, is hereby conveyed to all concerned that henceforth the registration of new OEM(s)/Model(s), except for Conventional Battery Vehicles & all unregistered vehicles, is allowed, during the extended period of Phase-I of the FAME-India Scheme i.e. upto 31st March, 2019 or till further orders, whichever is earlier. However, all such OEM(s) are advised to submit the desired details/documents strictly as per the General Operating Guidelines, issued by this Department earlier vide letters No. F.21(37)/NAB/DIDM/2014 dated 27th April, 2015 and 20th July, 2015 for Registration of OEMs and Vehicles Models. Copies of these orders are available on the website of the Department i.e. www.nic.in & FAME-India website i.e. fame-india.gov.in. The incomplete applications will be summarily rejected without any further communication to the respective OEM(s). As per the existing guidelines, each OEM is required to attach the following documents along-with their request for registration of OEM & Vehicle Models:

- 1. Application for manufacturer registration in Annexure-1;
- 2. Company Registration Certificate:
- 3. Trade License:
- 4. Excise Registration Certificate (GST):
- Sales Tax/VAT Registration Certificate (GST);
- 6. PAN Card
- 7. TIN No.
- 8. Service Tax Registration Certificate (GST);
- Testing/Homologation Certificate issued by the designated Testing Centre in satisfaction of VPQC and FAME-India Guidelines for each model of vehicles separately:
- 10. Pre-registration of xEV model as per Annexure-2.
- 11. MOA & Rules of OEM;
- 12. SMEV recommendation letter for 2W & 3W EVs, and
- 13. Photographs of vehicles
- The above decisions are applicable with immediate effect.
