MONTHLY SUMMARY OFSIGNIFICANT ACTIVITIES FOR NOVEMBER, 2017

This has reference to Cabinet Secretariats' DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of November, 2017 in the Department of Heavy Industry (DHI).

- E-office has been fully implemented in DHI from Ist November, 2017.
- 2. There has been excellent response to the call for Expression of Interest (EOI) from various States/cities for proposals for electric power train based multi model public transport. As on the closing date, proposals from more than 40 cities have been received. The proposals will be evaluated expeditiously and announcements of awards will be made during the Swachhatha Pakhwada from 16th to 31st December 2017, as already committed to the CoS on Swachhatha Pakhwada.
- M/s A.T. Kearney has been appointed as Consultant to assist in preparation of a comprehensive policy for the automotive sector.
- 4. On the arbitration matter invoked under Comprehensive Economic Partnership Agreement (CEPA) with Japan by M/s Nissan Motors Ltd., a meeting of the Inter-Ministerial Group (IMG) was held on 24th Nov., 2017 to discuss the terms of appointment of the arbitration tribunal. Based on the advice of the IMG, it was decided that Singapore would be the place for arbitration and Permanent Court of Arbitration, the Hague, would be the agency for case administration.
- 5. Under the FAME India Scheme, six (06) projects involving an outlay of Rs.29.36 crores were sanctioned under Technology Platform for Electric Mobility (TPEM) for technology development in the areas of High Power E-Vehicle Chargers, Driving Cycle, Motors and Drives for E-Vehicles.
- 6. A Cabinet Note for the modernization of Heavy Engineering Corporation Ltd (1TEC), Ranchi was circulated for Inter-Ministerial consultation. The proposal seeks to revitalize HEC Ltd., a historic player in the capital goods sector, with funds to be sourced through monetization of the land assets of the company with the consent of the Govt. of backhand.
- 7. Senior officials of DHI and heads of the CPSEs under DHI attended the full day brainstorming session conducted by Department of Public Enterprises on 6th November, 2017 at India Habitat Center, New Delhi in the context of the CPSE Conclave.
- 8. A meeting of Department related Parliamentary Standing Committee of DHI was held on 23rd November, 2017 in Parliament House Annexe, New Delhi.
- 9. Third meeting of Hindi Advisory Committee of Ministry of Heavy Industries & Public Enterprises was organised at Gangtok (Sikkim) under my Chairmanship.
- 10. BHEL was awarded "Champion of Change-Best Central Public Sector Enterprises" by Ministry of Skill Development & Entrepreneurship. IISSM Industrial Sector Safety Excellence Award, 2017 was also presented to BHEL.
